## Investment Objective & Strategy

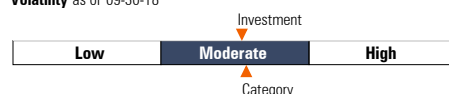
### From the investment's prospectus

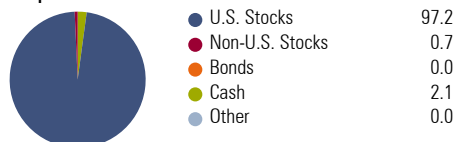
