Expense information has been restated to reflect current contractual rates. The adviser is contractually obligated to limit expenses to 1.25% for Class ADV shares through May 1, 2021. The adviser is contractually obligated to waive 0.019% of the management fee through May 1, 2021. Termination or modification of these obligations requires approval by the Portfolio's board.
