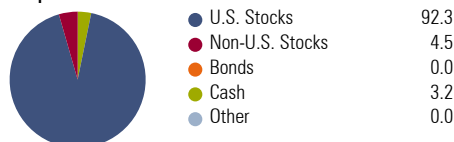

The contractual waiver may be terminated or modified prior to this date only at the discretion of the Board of Trustees.
