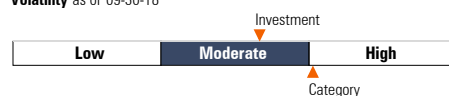
The investment seeks long-term growth of capital.

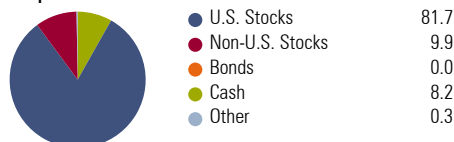
