**Investment Objective & Strategy****From the investment's prospectus**

The investment seeks to realize a total return that exceeds that of the Bloomberg U.S. Aggregate Bond Index.

The fund typically invests more than 90% of its assets in a diversified portfolio of fixed-income securities such as corporate bonds and notes, mortgage-backed securities, asset-backed securities, convertible securities, preferred securities and government obligations. It normally invests at least 80% of its assets in bonds and invests primarily in investment grade fixed-income securities. The fund is a "feeder" fund that invests all of its assets in a corresponding "master" portfolio.

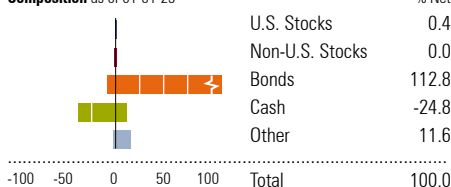

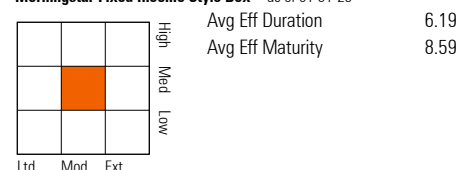

**Notes**

The Management Fee has been restated to reflect current fees. As described in the "Management of the Fund" section of the Fund's prospectus on page 36, BlackRock has contractually agreed to waive and/or reimburse fees or expenses in order to limit Total Annual Fund Operating Expenses After Fee Waivers and/or Expense Reimbursements (excluding Dividend Expense, Interest Expense, Acquired Fund Fees and Expenses and certain other Fund expenses) as a percentage of average daily net asset to 0.39% through June 30, 2026. The contractual agreement may be terminated upon 90 days' notice by a majority of the non-interested directors of BlackRock Bond Fund, Inc. (the "Corporation") or by a vote of a majority of the outstanding voting securities of the Fund. As described in the "Management of the Fund" section of the Fund's prospectus beginning on page 36, BlackRock has contractually agreed to waive the management fee of the Fund with respect to any portion of the Fund's assets estimated to be attributable to investments in other equity and fixed-income mutual funds and exchange traded funds ("ETFs") managed by BlackRock or its affiliates that have a contractual management fee, through June 30, 2026. In addition, BlackRock has contractually agreed to waive its management fees by the amount of investment advisory fees the Fund pays to BlackRock indirectly through its investment in money market funds managed by BlackRock or its affiliates, through June 30, 2026. The Total Annual Fund Operating Expenses do not correlate to the ratios of expenses to average net assets in the Fund's most recent annual financial statements and additional information, which do not include the restatement of the Management Fee and Acquired Fund Fees and Expenses. Other Expenses of BlackRock Cayman Master Total Return Portfolio II, Ltd. and BlackRock Master Total Return Portfolio Subsidiary, LLC (the "Subsidiaries") were less than 0.01% for the Fund's last fiscal year.
