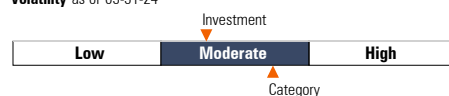

The fund diversifies its investments across industries and companies, and principally follows a large-cap value investment style.

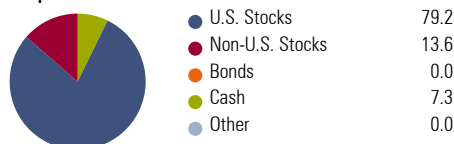
